* Winterization is strictly a preventative maintenance for the winter months and is not a cure-all for ANY engine problems you may be having. We recommend that your boat be stored with the fuel tank(s) FULL. *

AVOID A POSSIBLE \$5,000 FINE!!

NO WINTERIZATION OF BOATS KEPT ON LIFTS YEAR ROUND:

Did you know it is not possible to do a complete winterization legally while your boat is on a lift?

You can be fined up to \$5,000 from the US Coast Guard and additional fines may be imposed by the Department of the Environment and other state laws may apply. We have taken the time to research and verify the Federal Water Pollution Control Act and the local environmental regulations. It is illegal to fog engines while on a lift and changing lower unit fluid is unlikely to be performed without some discharge ending up in the water. You may find some individuals or contractors offering this service, but please be aware, many do not have business licenses or liability insurance and the homeowner or boat owner will be the one responsible for the fine and cleanup. It is also important that your boat be taken out of the water for winter layup and preferably be shrink wrapped to avoid unnecessary deterioration of gel coat, upholstery covers and tops. A good compounding and waxing could also be done during this time whether by yourself or by your dealer.

POSSIBLE WARRANTY COVERAGE DENIAL DUE TO IMPROPER MAINTENANCE

Routine maintenance outlined in the operation and maintenance manuals from your engine manufacturer must be performed in a timely manner in order to maintain warranty coverage.

Manufacturer may reserve the right to make warranty coverage contingent upon proof of proper maintenance. Service should be completed by an authorized dealer that uses genuine parts, oils, and lubes.

You have a substantial investment in your boat and motor. Make sure to protect your investment by having a certified dealership take care of your service needs. Your boat will be worth more at resale or trade-in time with proper maintenance records.
